**AN ORDINANCE ESTABLISHING SALARIES FOR  
CITY EMPLOYEES EFFECTIVE MAY 1, 2023.**

BE IT ORDAINED, by the Board of Aldermen, City of Carl Junction, Missouri, as follows:

1. The salaries for the positions set forth in exhibit "A", which is attached hereto and incorporated herein, shall be effective as of May 1, 2023.
2. The Board shall herein grant the City Administrator with the approval of the Mayor authority to authorize the hiring and pay rates of "as need" employees are herein defined as employees needed by a department for less than five consecutive days labor, to fill a specific manpower need within the department.
3. The Board shall set the rate of pay for seasonal or part-time workers at the time the Board authorizes the position(s) to be filled.
